In view of the appointment of new trustees and to compile the various clauses of the **Original Deed of Trust** executed on 27th December 2002, the continuing trustees have agreed to and decided to reproduce all the clauses with such modifications as required. 6. Registered Office: The registered office of the Trust shall be at **NANDAGOKULA LAYOUT, NAGAWARA THANISANDRA MAIN ROAD, NAGAWARA VILLAGE, KASABA HOBLI, BANGALORE NORTH TALUK- 560045** and the said registered office may be shifted to such other place as the Trustees may decide.
7. *Clause deleted as it is redundant*
8. The Author has this day, endowed a sum of Rs.1000/- only to the Trust and has delivered the said amount to the Trustees. The Trust hereinafter should stand possessed of the aforesaid Trust property and all other properties that may come to its possession.
9. **Properties of the Trust.** The Trust shall be entitled to receive and acquire both movable and immovable properties by way of any alienation of immovable property shall be done as with the prior approval of the Director of Income Tax (Exemptions), Bangalore, gifts, donations, sales, lease, exchange etc., from the public, State Government, Central Government or from abroad. The Trust shall be entitled to make investment of the Trust property in such a manner as the Trustees may deem fit and beneficial to the Trust.

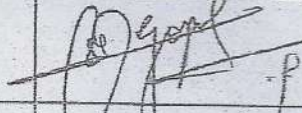
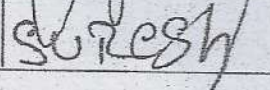

12. The Trust hereby created is not revocable either at the instance of the Author of the Trust or otherwise at any time or under any circumstances.

13. Board of Trustees.

- The author of the Trust hereby constitutes, nominates and appoints the TRUSTEES and also appoints Board of Trustees consisting of the persons named above.
- The total strength of the Board of Trustees shall not be more than 12 and not be less than three.
- The members of the Board of Trustees shall have power to co-opt one or more persons as members of the Board of Trustees for such period as they may deem fit and fill-up the vacancy in the Board within the aforementioned limits as they may deem fit from time to time subject to a maximum of twelve. Any persons appointed as member by the Board of the Trustees shall hold such office only for such period for which he/she is appointed or till he/she voluntary resigns.
- Minimum three Trustees may constitute a Board when the numbers of members are reduced. Such members shall have right to co-opt one or more members of the Board of Trustees and fill up any vacancy the Board, however, the Author of the Trust shall have a right to nominate one or more persons as Trustees and each person so nominated shall have right to nominate further. The consent of the Board is not necessary for such nominated person to be a Trustee and such nominated Trustee is included for all business of the Trust.
- A member of the Board of Trustees, other Author of the Trust, may be removed in good faith, provided at least majority of two-thirds of the members of the Board of Trustees as constituted from time to time give their consent to the removal of such member.

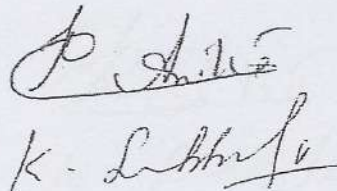

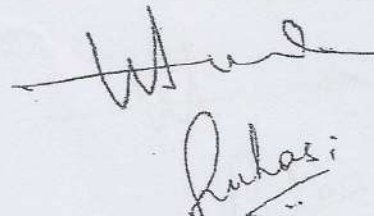

- f) The Board of Trustees shall be responsible for maintenance of accounts and for the various activities of the Trust and shall conduct the activities of the Trust in accordance with the stipulations set out herein and for fulfilling the objects of the Trust and conduct affairs in accordance with law. The Board of Trustees may delegate all or any of the powers vested in it such person/s for time as it may deem fit and may revoke, vary, alter, rescind such powers so delegated.
- g) The Board of Trustees may appoint one or more among them to do such activities as may be assigned with such designation as may be found suitable and shall have power to fix the duties, responsibilities, salaries, powers, period of office, etc., of the persons so appointed. However, the Board shall have power to remove any person from any office even prior to the expiry his/her period of office by a resolution passed and accepted by majority of members of the Board as constituted at that time.
- h) The Board of Trustees shall have power to make rules for admission of Associate Members, life members, fellow members or persons with such designation as they may deem fit on such terms and conditions as they may deem fit and may vary the terms and conditions and rules governing such admission. Any person admitted under the rules framed by the Board shall not have right to interfere in the management of the Trust.
- i) The Board may manage the affairs of the Trust by appointing such committee or delegating all the powers to Managing Trustee as the may deem fit from time to time. The Board shall have power to frame the rules and regulations, terms and conditions, of committee or such other bodies formed for the management of the affairs of the Trust and shall also have powers to vary the constitution of the management of the Trust.
- j) The powers vested in the Board shall be excised by a resolution passed at a meeting of the Board or circulated among the members of the Board and accepted

by a majority of members. In case of tie, the Author of the Trust shall have an additional vote called casting vote.

- k) The Board shall have all the powers for proper running of the Institutions and for achieving the objects of the Trust to the fullest extent. They shall have powers to receive donations, contributions, money or any other assets in any shape or form and to hold the same as part of the capital fund or corpus of the Trust. However, any funds or assets that is received shall be used only for advancing the objects of the Trust and no portion would in any way distributed to Trustees or persons defined under section 13(1)(c) of the Income Tax Act.
- l) The funds of the Trust shall stand invested as per section 11 (5) of the Income Tax Act.
- m) They shall have power to acquire, to lease or purchase or otherwise to sell, mortgage, lease or transfer in any other manner whatsoever properties, movable or immovable, to construct hostels or any other buildings and carry out other improvements thereof for the purposes of the Trust and to manage and deal with properties, movable or immovable and other assets of the Trust and to pledge them, to repay loans or otherwise and to deal generally with the assets of the Trust for the purpose of the Trust.
- n) They shall have power to receive, collect or realize or cause collection or realization of all interest, dividends, bonus or premium that accrues or become due on all or any stock, funds, securities, shares, debentures, deeds or documents of like nature.
- o) They shall represent the Trust in all Courts (original and appellate) or before any authorities or departments of the Government of local authorities.
- p) To excise or negotiate papers and documents (whether negotiable or non-negotiable) to receive moneys or other assets and to grant receipts and discharges.

- q) To sign and verify all pleadings, memorandum of appeal, petitions and application of all kinds to compromise, abandon or refer to arbitration and whole or any part of the claim by or against the Trust, to engage lawyers and to take all such other necessary steps.
- r) To borrow for the purpose of the Trust on personal credit of the Trust with or without charge and responsibility upon the assets of the Trust.
- s) To meet all the necessary expenses incurred or to be incurred in connection with the creation and execution of this Trust.
- t) To open and maintain accounts of any nature in any bank/s authorize operations of the said accounts by the Author of the Trust.
- u) To enroll patrons, life members, vice patrons, members in such other capacities as the Board of Trustees may deem fit and frame rules of the enrolment and other matters relating to such position.
- v) To pay out of the Trust funds, salaries, wages, rent and other expenses relating to the administration of the Trust or relating to any activities or other affairs of the Trust.
- w) To do all other acts, deeds, matters and things which may be deemed necessary for carrying out the objects of this Trust or its administration.
- x) The Board of Trustees shall have power to delegate all or any of the powers vested in them by these presents to any other trustee/s or any other persons/s for the purpose of conveniently managing and exercising such powers.
- y) The powers enumerated in clause (r) above shall be exercised by the Board of Trustees subject to their satisfying the conditions laid down under section 11, 12 and 13 of the Income Tax Act 1961 as amended from time to time so that the

- z) The powers vested in the Board of Trustees shall be exercised according to the decision of majority of the members of the Board of Trustees and by way of resolution passed either by circulation or at the meeting of the Board of Trustees.
14. The Author of the Trust shall be Managing Trustee. The Managing Trustee may convene the meeting of the Board by serving notice of the meeting on the other members of the Board in writing and setting out therein the matter to be discussed the place of meeting, day, date and time of the meeting with at least three days of clear notice. However the requirements of the three days notice may be waived or the shorter notice may be ratified by a majority of the members of the Board. The day to day management of the Trust shall be vested with the Managing Trustee and she shall be entitled to take decision in respect of all matters required for day to day management.
15. The office of the members of the Board of Trustees shall be honorary; the quorum for the meeting shall be three. The Board shall met at least twice a year and as and when necessary.
16. The Board of Trustees shall cause true and correct account to be kept of the sums of moneys received and expenses incurred on behalf of the Trust. Once atleast in every year, the accounts of the Trust shall be examined and correctness of the accounts and balance sheet shall be ascertained by a Chartered Accountant appointed by Board of Trustees and shall be counter signed by all the members or by the Managing Trustee and other Trustees.
17. The Board of Trustees shall have power from time to time to make and alter such rules and regulations with regard to the conduct of the business and all matters duly vested in them as they may think fit, however the same shall be carried out only after specific approval of the Director of Income Tax (Exemptions). 18. Nothing contained in this Deed shall be deemed to authorize the Trustees to do any act which may in any way be construed as contrary to the provisions of Section 2(13), 11, 12, 12A, 13 and/or 80G of the Income Tax Act 1961 or any statutory modification thereof and all activities of the Trust shall be carried out with a view to benefit the public at large without any profit motive and in accordance with the provisions of the Income Tax Act, or any statutory modifications thereof.
19. The members of the Board of Trustees shall be indemnified against any expenses and losses incurred or suffered or an payments made by them in the administration of the Trust and such expenses, losses and payments shall be borne by the Trust and none of the members of the Trustees shall in any way be personally liable or responsible for the same. Any member of the Board may resign such membership and such member shall cease to be a member upon the acceptance of this resignation by the Board.
20. Any of the members of the Board of Trustees may be chargeable only for such moneys or securities as she/he/they shall actually receive and shall be answerable and accountable for his/her/their own acts, receipts, deliberate, neglect or defaults and not for those of others nor for any banker, auctioned or person with whom or into whose hands any Trust money or securities may be deposited or come for sufficiently in title or deficiency in value of any investment or for any other loss unless the same shall happen through his/her/their own willful act or defeat.
21. The members of the Board of Trustees may reimburse themselves or pay and discharge out of the said Trust properties and expenses incurred in or for the execution of the Trust and powers of these presents after getting sanction of the Board which will not be unreasonably withheld.
22. This Trust may be extinguished at any time if the two thirds of the majority of the members of the Board of Trustees decide to extinguish the Trust. Upon dissolution of

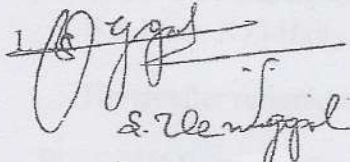

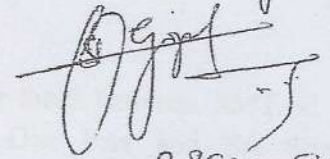
